

## INVITATION FOR BIDS

Sealed bids for Contract No. TU-201M, Furnishing Low Pressure Sanitary Sewer Pump Stations and Appurtenances for the Spring Lake Sewer District – Phase 1, Town of Ulster, Ulster County, New York, are sought and requested as set forth in drawings and specifications prepared by Brinnier and Larios, P.C., 67 Maiden Lane, Kingston, New York 12401.

The contract will have one (1) Proposal: Furnishing Materials. Bidders must bid on all items in the proposal.

The proposal is for the procurement of sanitary sewer grinder pump stations and appurtenances.

Separate sealed proposals completed on forms provided with the Contract documents shall be received by the Town of Ulster, Ulster County, New York at the Town Hall until 10:00 AM on Friday, August 21, 2020 at which time they will be publicly opened and read aloud.

Bids received after the designated date and time will be considered unresponsive and returned to the bidder unopened.

Attention is directed to the fact that the Contractor will be governed by New York State Labor Standards Provisions, which are made part of this specifications and contract.

The bidder shall sign and submit with his proposal, the Certification of Non-Collusion form that certifies that he is fully aware of the State laws regarding the non-collusion bidding certification.

The Town Board expressly reserves the right to waive any informalities in or to accept and any bid, or to reject any and all bids, or to award on any or all items, as the interest of the Town of Ulster may appear to require.

The Town of Ulster is an exempt organization under the Tax Laws and is exempt from payment of Sales and Compensating Use Taxes of the State of New York and Cities and Counties of the State of all materials which are to be incorporated into the project, pursuant to the provisions of the Contract. These taxes are not to be included in the Bid.

No bidder may withdraw his bid within 60 (sixty) days after the actual date of the opening thereof.
