Sealed Bids for the Replacement of Water Mains and Appurtenances – Phase 3 for the Kerhonkson Water District will be received, by Town of Wawarsing, at the office of the Town Clerk, Town Hall, 108 Canal Street, Ellenville, New York until 11:00 AM local time on May 8, 2019 at which time the Bids received will be publicly opened and read. The Project consists of the following: General Construction work consisting of replacement and/or installation of 8” and 10” diameter PVC and HDPE water mains, valves, hydrants, fittings, and house services, including, but not limited to maintenance and protection of traffic, site preparation and restoration, trenching, directional boring, and removal of asbestos-cement pipe, and other related work.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis, as indicated in the Bid Form.
